CTC seminar at Strathmore University in Nairobi

On 22nd October Strathmore University, Law School in Nairobi, Kenya hosted a conference on the Cape Town Convention, the Rail Protocol and the proposed MAC Protocol focusing on the legal and economic benefits for African states, international trade and development. Speakers included Professor Ignacio Tirado, Secretary General, UNIDROIT, Anna Veneziano, Deputy Secretary General, UNIDROIT, Galetlolwe Semenya, Senior Manager, PRASA, Soteri Gatera, Chief of Industrialisation and Infrastructure at the Economic Commission for Africa (UN ECA), Teresa Rodríguez de las Heras Ballel, Professor of Commercia Law, University Carlos III, Madrid, Howard Rosen, Chairman of the Rail Working Group and a number of leading international academics and legal experts.

Presentation to the UN ECE

RWG chairman Howard Rosen will be leading a delegation to the Working Party on Rail Transport of the Inland Transport Committee of the United Nations Economic Commission for Europe (UNECE) taking place in Geneva, between 25th and 27th November 2019. On 26th November he will be making a presentation to delegates on the Luxembourg Protocol and the Working Party will also be considering a request from Luxembourg to establish a group of experts to look at the protocols for permanently identifying rolling stock (see **Topic of the month** below).

Topic of the month: What do we mean by "permanent"?

The ability uniquely to identify railway rolling stock is critical for the effective operation of the Luxembourg Rail Protocol. But unique identification is becoming increasingly important commercially, for example facilitating tracking of the status and location of equipment in real time, predictive maintenance programmes and more efficient accident analysis for liability and insurance.

Article XIV of the Luxembourg Rail Protocol requires that the unique identifier is "affixed" to the rolling stock directly or associated in the international registry with an identifier "affixed" to the rolling stock. The latest draft of the regulations set out a new global unique identification system for all railway rolling stock system known as the Unique Rail Vehicle Identification System or URVIS. They state that: "URVIS identifier" means, in respect of an item of railway rolling stock, the unique, 16-digit identification number allocated in accordance the regulations. However so far there are no technical guidelines as to how the identifier is "affixed". Logically this identifier must be affixed in a way which is permanent or if it needs to be replaced, for example as a result of damage, the conditions for a "safe" replacement will need to be specified.

Clearly painted numbers will be unsatisfactory because they are not permanent and can be obscured or painted over. In the past the obvious permanent marker would have been either a metal plate glued or welded onto the equipment or a stamp on the chassis somewhere. But technology moves on. Now it could be a box containing RFID chips or other electronic devices fixed permanently to the wagon. There also need to be protocols governing the size of the identifier(s) and its ability to be read by human agents with or without electronic machines, the accessibility of information if it is stored electronically in a box permanently affixed to the rolling stock or in the cloud if the information is accessible through the Internet using, for example, a QR code on the rolling stock. And who should have access to this information? Should it be open or limited access? Moreover, any protocols would need sufficient flexibility to take into account technological developments in the coming years.

Hopefully these issues will be considered by the Working Party on Rail Transport of the Inland Transport Committee of the UNECE in Geneva in late November. There are no instant answers on these issues; they will need to be considered by a committee of experts to ensure that any marking of rolling stock will be easy, cost-effective and efficient - but in all cases permanent.
